# Heavy metal impact on fetus

In the early stage of pregnancy, the fetal organs are under critical process of differentiation. The key organs (heart and lung etc. ) , skeleton and nervous system are developing in this process. The differential growth of cells will be influenced if they are disturbed by any toxins.
